MEETING DATE: JANUARY 24. 1987

The committee meeting began at 10:35 am. Darlene Galindo introduced herself, and the persons who were present. She explained that the Muscle Beach Venice membership committee is forming to enable the larger membership to have a voice, and a structured group for projects and activities. Darlene then indicated that this first meeting will be relatively informal with no official officers or members at this point. She also suggested that Steve Ford act as temporary chairman, as he had created the meeting agenda for distribution.

Steve Ford thanked Darlene for the opportunity to help, and for her bringing the group together in the new formal structure. Steve asked members to refer to, and follow, the agenda items for discussion.

- I. Discussion of Committee - Purpose and Structure
  - A. Steve explained that Muscle Beach Venice needs internal support from its membership, and that this committee will provide a valueable tool. He suggested, that if other persons present agree, meeting elections will occur at the February meeting.
  - B. Determine committee membership roles and responsibility.
    - 1. The following comments were made about committee membership:
      - \* Bill Howard-members should set an example and be conscientious about the needs of the facility. Most

important is that Muscle Beach Venice represents the bodybuilding capitol of the world and members should seek ways to help the facility improve.

- \* Joe Mack-agreed with Bill Howard that Muscle Beach Venice should be the hub of bodybuilding and weightlifting.

  Also he wants the committee members to work as a unit solving problems and meeting needs to help make Muscle Beach Venice world famous and proud.
- \* Darlene Galindo-said that she would like to see Muscle
  Beach Venice brought to national recognition. She hopes
  that members will work to create a positive image, support
  the upgrade of the facility and assist in the maintenance
  of the training area.
- \* Art Baker-the committee should work to improve and expand events such as bodybuilding and powerlifting at Muscle Beach Venice. These areas need particular coordination.
- \* Bud Mucci-Committee members should accept their roles as examples for other members. Committee members should take extra pride in the facility and look for areas to improve.
- \* Malcolm Arnold-committee members may work together to see that the revitalization of the pen is a success. The city has not given a lot of attention to the facility, and this committee is in a position to help get the action needed.
- \* Steve Ford-He explained that committee members should help encourage other members to care for and take pride in Muscle Beach Venice, and work like a family to help make Muscle Beach Venice a reality as the attractive outdoor training facility available.
- C. Discussion of sub-committee functions

  Steve Ford explained that each committee member may take

part in separate efforts of specific projects as part of a sub-committee. He pointed out that the special sub-groups will be determined later.

- II. Discussion of Muscle Beach Venice events for 1987
  - A. Bill Howard reviewed annual event plan including
    Master and Open/Men's and Women's and Mr./Ms. Muscle
    Beach Contest. Bill requested additional publicity this
    year such as posters and colorful literature.
  - B. Joe Mack introduced the idea of having junior events for junior and senior high students. Bill Howard suggested parents' signatures for such entrant (minors). Joe Mack agreed to head up junior event sub-committee.
  - C. Bud Mucci reviewed need for return of weightlifting events, and suggested obtaining official sanctioning for future dates. Darlene agreed to objectives of 1987 event planning, and will coordinate with Bud Mucci. It was determined that a Muscle Beach Venice Open Powerlifting Contest would occur in August, and a second contest in October.
- III. Discussion of Special Muscle Beach Venice Sign Unvailing.
  - A. Darlene explained that the official Muscle Beach Venice sign would be produced within two months. She indicated that the committee may wish to create a special day for the unvailing.
  - B. Committee members discussed obtaining as much media exposure as possible. Bill Howard suggested invite Arnold Schwarznegger, Joe Gold and Mayor Bradley. Additionally, Bill Howard will be the Master of Ceremonies for the event. Steve Ford requested handling public relations. The committee agreed to focus together on



on coordinating events for the special day of the unvailing. The date is yet to be determined.

Steve Ford and Joe Mack presented the finished full-size

official "Muscle Beach Venice" sign for committee review and approval. The committee welcomed and approved the completed sign.

1. Determination of date and time for official unveiling to public.

 The committee discussed possible dates for official dedication of "Muscle Beach Venice" sign. The initial proposed dates are either April 4. April 11 or April 18.

2. Steve Ford suggested a "Muscle Beach Venice" Bar-B-Que or picnic party to coincide with official unveiling.

Darlene suggested contacting the fire department to learn if they would belp with a bar-b-que.

3. Clean up Committee

Joe Mack was unanimously chosen by the committee to lead
a "Muscle Beach Venice" clean-up committee. This committee
will spend one or two Saturday mornings painting and cleaning
the training area.

B. Public Address System for Special Events

for training as a part of their specialized physical
education. Joe will contact L.A. City schools; Steve
Ford to assist.

3. Powerlifting Contests
Bud Mucci reported contest preparation is on schedule.
He told the committee that he needs entry forms produced as soon as possible. Bud Mucci to follow-up with Darlene on the forms: Steve Ford to assist with form design.

Public Relations
Steve Ford explained that he is preparing for action on the "Muscle Beach Venice" sign unveiling. He has contacted Mayor Bradley's office. Bill Howard is following up with Arnold Schwarzenegger; Darlene Galindo will contact Pat Russell's office.

5. Equipment Committee

Jerry Werling reported that he is preparing a list of equipment and has investigated obtaining fitness products

from Dennis Tenerino. Steve Ford reported he has initiated an estimate from Dan Howard, equipment builder from Joe Gold's World Gym. Jerry to follow-up with the equipment list.

#### I. Call to Order

Chairman Bill Howard called the meeting to order at 10:10 a.m.

#### II. Introduction of Members

Persons present individually identified themselves members and quests present were: Bill Howard, Chairman

#### III. Topics for Discussion

A. The new and proposed final "Muscle Beach Venice" weight training and stage area plans were presented for discussion and review by Charles Chu of the City of Los Angeles Department of Recreation and Parks. Discussion followed. Members debated advantages/disadvantages of having storage facility at north or south end of training area.

Members voted to approve/endorse plans as presented. majority of members present voted to request that Charles Chu design the facility with the storage building at the south end of the facility.

After the vote Bill Howard thanked Charles Chu for taking his own time to visit for the meeting, as well as extending himself to meet the requests of "Muscle Beach Venice" membership.

- B. Unveiling of new "Muscle Beach Venice" sign
  - 1. Darlene Galindo reported that it is hoped that a representative council person will be available for the unveiling, but that she was not certain that the council person would be Pat Russell. There will be an election on April 14 in which Pat Russell may or may not, obtain another term. Darlene indicated that a letter should be written to Ms, Russell's office requesting her appearance, regardless of the election, and the committee should go on with plans for a May 31 unveiling.
    - 2. Steve Ford reported that he has inquired with Mayor Bradleys office regarding an appearance by the Mayor on May 31. He that he must follow up with Mayor Bradley's office in a letter he will write. Steve reported that he is establishing a media contact plan to publicize the May 31 event, as well as preparing a plan to obtain "clean-up" day publicity for Joe Mack's committee.
    - 3. Bill Howard reported that he has been in touch with Arnold

Schwarzenegger's office about Arnold's possible May 31 appearance. Arnold indicated to Bill that May 31 was too far away to know his schedule as a definite. Bill will remain in contact with Arnold to learn his availability. Bill stressed the need of three primary committees to immediately begin action and preparation for the May 31 date: Physique Committee; clean-up committee; and public relations/picnic committee. All members present agreed to support the project between monthly meetings.

#### C. P.A. System

Darlene Galindo reported a P.A. system status update on on behalf of Art Baker, who was not present. Art's P.A. system contact could not promise to hold his system until we received quotes from two other sources, since it was over \$500.00 and he works in a pawn shop. Darlene did note her gratitude. Darlene will follow-up.

- An incidental comment was made by Steve Ford and discussion followed with Bill Howard about future plans including underground wiring for the P.A. system at the new Muscle Beach Venice facility. Bill suggested that he meet with Charles Chu at a later date to discuss specifics on the future P.A. system wiring

#### IV. Committee Reports

- A. Clean-up Committee Joe Mack and Malcolm Arnold reported that they had met and determined a supply list for the clean-up day. Additionally they suggested using 12 to 20 people on the program. Malcolm Arnold reported that the committee will investigate food options for the clean-up day. Bill Howard suggested contacting Annie's Restaurant adjacent to the Muscle Beach Venice Area. Malcolm said the committee will investigate options. The proposed clean-up day is Saturday, May 16, 1987, beginning at 7:00 a.m.
- B. Equipment Committee Jerry Werling provided a list of equipment recommendations for review. Jerry indicated his equipment list shows to much equipment to fit into the new weight-training area as designed. Bill Howard asked that Jerry reevaluate his equipment consideration. Bill Howard asked Jerry if he could design equipment for the plans that the committee just accepted in a vote. Jerry indicated that he could not.
- C. Powerlifting Committee Darlene reported for Bud Mucci in his absence. The committee needs to get further information as soon as possible on sanctioned powerlifting events. Malcolm volunteered to assist.
- D. Teenage Training Program Committee Joe Mack reported that he has planned a program to help youngsters train with weights. He expects to assemble a morning training program in coordination with physical education departments from the L.A. school system.

#### V. Old Business

Bill Howard and guest member Clifford Mosby suggested further investigation of Muscle Beach Venice logo design trade mark or design registration. The committee suggested having the artist involved with volunteer work with Steve Ford sign a formal release for his involvement with the logo. Steve explained that the artist has requested compensation for the design, if it is possible.

The committee responded indicating that the city has agreed through Darlene's approval, to create a paid finished "mechanical" of the logo artwork, to be done by the design artist, but never entered or contracted into an agreement to solicit the initial design artwork originally submitted to the city in 1986. Steve agreed that the project was a volunteer proposal idea, but suggested that people might offer personal contributions by ond the city's payment for the finished "mechanical" art. The committee accepted Steve's suggestion, and also suggested that the artist receive credit in all articles, where possible, arising from the official title, as well as be offered the option of putting his name somewhere on the logo at this time, if the artist wishes.


